Career and Technical Education Programs Highlighted at Selfridge Air National Guard Base

Fraser High School was the exclusive high school partner to showcase its Career and Technical Education [CTE] programs at the Selfridge Open House, Air Show, and STEAM Expo held in early June.



Major Kraig Lohse, director of the Open House, and Chief Master Sergeant Tim Huhtasaari invited FHS to be the

Open House's CTE partner after visiting the school last November and viewing CTE programs across the region.

To spearhead the effort, more than 80 FHS students went to Selfridge for a work-based learning field trip in May and learned about the opportunities for military and civilian careers at the Air National Guard base.

During the June event, CTE staff and student volunteers welcomed more than 135,000 visitors through the STEAM Expo. Visitors learned about how their students could follow career pathway training in Fraser, including:

Staff and students working the event shared in enjoying an all-time high in morale while reflecting with current, former, and future students about the success they can achieve when they put purpose and planning behind career pathway training.

The partnership between Selfridge and FHS will continue into the future.

Bond Work CONTINUES

As soon as school ended in June, crews began the process of removing the old boilers from Disney and Emerson elementary schools. New boilers and equipment were installed in July and will be ready to consistently heat the buildings this fall when students and staff return.

The boiler replacement at these two schools is part of the \$59 million bond approved by voters in 2023. This equipment not only helps keep our schools open and safe for students to attend throughout the winter months, but it also provides improved energy efficiency throughout the buildings.



During the last school year, the district replaced all external window shades at every school, which will help reduce the schools' energy costs and create a barrier from severe temperatures, making classrooms more comfortable. The shades will also provide additional privacy and security.

Early Childhood Options Continue to Expand

Fraser Public Schools is committed to providing an early childhood learning opportunity that fits every family. All options feature small class sizes and qualified teachers, and are open to all Macomb County residents.

At the Dooley Center for Little Learners, the district's dedicated early childhood building, a myriad of programs are offered for children as young as 18 months.

This includes toddler time, a weekly parent and child play group; tuition preschool for 3- and 4-year-old students that meets for a few hours two or three days a week; and GSRP preschool for 4-year-olds that is free or low cost for those

who qualify and meets all day Monday-Thursday. The Center also hosts our early childhood special education program.

The Dooley Center offerings have continued to evolve to meet the needs of our community. During the last few years, improvements have been made to make the school more accessible to our littlest learners. The playground was improved through the 2023 bond program, and an indoor play area to improve gross motor skills was installed after the district received a grant this spring.

Registration for all programs is currently open, but spaces are limited. Visit dooley.fraser.k12.mi.us to begin enrollment.

THE GRIEVANCE PROCEDURE IS ESTABLISHED TO MEET THE REQUIREMENTS OF TITLE II OF THE AMERICANS WITH DISABILITIES ACT OF 1990, TITLE VI OF THE EDUCATION AMENDMENT ACT OF 1972, TITLE IX OF THE EDUCATION AMENDMENT ACT OF 1972, SECTION 504 OF THE REHABILITATION ACT OF 1973, AND THE AGE DISCRIMINATION ACT OF 1975.

Section I: Any person may use this grievance procedure to file a complaint of discrimination on the basis of race, color, national origin, sex, disability, or age in the programs or activities that are provided by Fraser Public Schools. The grievance may be brought forward to the Local Civil Rights Coordinator, who is identified by name and job title as:

Section II: The person who believes he/she has a valid basis for grievance shall discuss the grievance informally and on a verbal basis with the local Civil Rights Coordinator, who shall, in turn, investigate the complaint and reply with an answer to the complainant. He/she may initiate formal procedures according to the following steps.

Step 1: A written statement of the grievance signed by the complainant shall be submitted to the Local Civil Rights Coordinator within five (5) business days of receipt of answers to the informal complaint. The Local Civil Rights Coordinator shall further investigate the grievance and reply in writing to the complainant within five (5) days.

Step 2: If the complainant wishes to appeal the written decision of the Local Civil Rights Coordinator, he/she may submit a signed statement of appeal to the Superintendent of Schools within five (5) business days after receipt of the Coordinator's response. The Superintendent shall meet with all parties involved, formulate a conclusion, and respond in writing to the complainant within ten (10) business days after receipt of the coordinator's response.

Step 3: If the complainant remains unsatisfied, he/she may appeal through a signed, written statement to the Board of Education within five (5) business days of his receipt of the Superintendent's response in Step 2. In an attempt to resolve the grievance, the Board of Education shall meet with the concerned parties and their representative

within forty (40) days of the receipt of such an appeal. A copy of the board's disposition of the appeal shall be sent to each concerned party within ten (10) days of this meeting.

Step 4: If at this point the grievance has not been satisfactorily settled, further appeal may be made to the Office for Civil Rights, Department of Education, 600 Superior Avenue East, Suite 750, Cleveland, OH 44114.

Inquiries concerning the nondiscrimination policy may be directed to Office for Civil Rights, Department of Education, 600 Superior Avenue East, Suite 750, Cleveland, OH 44114.

The local Civil Rights Coordinator, on request, will provide a copy of the district's grievance procedure and investigate all complaints in accordance with this procedure.

A copy of each of the acts and the regulations on which this notice is based may be found in the Local Civil Rights Coordinator's office.

AHERA (ASBESTOS HAZARD EMERGENCY RESPONSE ACT)

The Environmental Protection Agency has determined that airborne asbestos fibers can be a health hazard. The Asbestos Hazard Emergency Response Act (AHERA) was passed in 1986. District buildings are monitored every six months and inspected every three years to comply with AHERA regulations. The last inspection was completed in 2016. Updated Management Plans are located in the office of each building and in the Operations & Maintenance Building. Each plan shows asbestos-related work that has occurred in each building.

REPRODUCTIVE HEALTH AND SEX EDUCATION INSTRUCTION – STATE AID ACT, 1766A

The Board of Education has established a program of health instruction that includes reproductive health and other sex education instruction, as well as serious communicable disease prevention education.

According to applicable law, parents/guardians have the right to review materials or observe classroom instruction; please contact your student's school principal.

This statute also allows you to excuse your child from participation in classes that include such instruction, if you choose. If you wish to exercise your right to excuse your student from this instruction, please send written notice to your student's school principal.

BADGE SYSTEM FOR VISITORS, VOLUNTEERS, AND GUEST TEACHERS

For security purposes, the district is continuing its practice of requiring all visitors, volunteers, and guest teachers to wear an identification badge while in any school building. All persons entering a school building are requested to immediately report to the main office to obtain an identification badge.

FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA)

The Family Educational Rights and Privacy Act (FERPA), a federal law, requires that Fraser Public Schools, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Fraser Public Schools may disclose appropriately designated "directory information" without written consent, unless you have advised the district to the contrary in accordance with district procedures. The primary purpose of directory information is to allow the Fraser Public Schools to include this type of information from your child's education records in certain school publications. Examples include:

- A playbill, showing your student's role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs; and
- Sports activity sheets, such as for wrestling, showing weight and height of team members.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965 (ESEA) to provide military recruiters, upon request, with the following information: names, addresses, and telephone listings, unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.

If you do not want Fraser Public Schools to disclose directory information from your child's education records without your prior written consent, you must notify the district in writing by the end of the second week of the school year. Fraser Public Schools has designated the following information as directory information:

- Electronic mail address
 - Photograph
 - Participation in officially recognized activities and sports
 - Degrees, honors, and awards received
 - Major field of study
 - The most recent educational agency
 - Dates of attendance and institution attended
 - Grade level
 - Student ID number, user ID, or other unique personal identifier used to communicate in electronic systems that cannot be used to access education records without a PIN, password, etc. [A student's SSN, in whole or in part, cannot be used for this purpose.]
- Written complaints can be filed with Mr. Kerry Terman, Fraser Public Schools, 33466 Garfield Road, Fraser, MI 48026.

DRUG-FREE SCHOOLS

Drug-Free Schools and Communities Act of 1996 (amends Michigan Public Health code) Public 174 of 1994

The "drug-free zone" surrounding school property is 1,000 feet. Any individual who delivers cocaine, narcotics, or certain other illicit substances to a minor student within the 1,000-foot drug-free zone around the school property shall be punished by at least two years in prison and up to three times the term of imprisonment and fine – or both – that would otherwise apply. "School property" is defined as a "building, playing field, or property used for school purposes to impart instruction to children in kindergarten through grade 12, when provided by a public, private, denominational, or parochial school, except those buildings used primarily for adult education or college extension courses."

PEST MANAGEMENT PLAN

Dear Parent/Guardian: As a part of the Fraser Public Schools Pest Management Program, pesticides are occasionally applied. You have the right to be informed prior to any pesticide application made to the school grounds and buildings. In certain emergencies, pesticides may be applied without prior notice, but you will be provided notice following any such application. If you need prior notification, you may notify the school district in the following ways:
