CAREER AND TECHNICAL EDUCATION PROGRAM A Fraser Point of Pride

The Fraser Public Schools Career and Technical Education (CTE) program is focused on instilling a positive work ethic in students by providing them with real-world opportunities and experiences.

"The Career and Technical Education program is an educational model that combines high school and post-secondary academics with credentialed hands-on training to prepare students for their careers of choice," says Ms. Abby Sandusky, Director of Career and Technical Education.

Offering 12 State-certified programs, Fraser's CTE program is equipping students with the skills necessary to meet the high demands of today's industry.

"CTE draws its curriculum from the workforce, meaning standards remain fluid and flexible," says Sandusky.

In order to remain up to date and relevant, as changes and advancements happen in industry, teachers make adjustments

to their instruction. As such, continuous communication with industry and advisory committees is also critical to meet the needs of employers.

"It's crucial that we're connecting with industry partners to ensure that there is a relevant next level of skills application and training for our students in the form of apprenticeships, on-the-job training, and employment with organizations that support student growth through tuition reimbursement," says Mr. Brent Brasure, Work-Based Learning Coordinator and Industrial Technology department head. "Automotive supplier Anderson-Cook recently hired six graduates from our program to address industrial demands."

My Child's Bus Stop

FIND YOUR CHILD'S BUS STOP ONLINE

Bus stop information will be available online for the 2015–2016 school year starting on August 27. You can access your child's bus stop information by visiting www.fraser.k12.mi.us or by visiting your child's school website. Click on the "My Child's Bus Stop" link and enter your address to retrieve your child's bus stop information. **It is very important to check your child's bus stop, as routes have been modified for the 2015–2016 school year.**

Students will be assigned a route number in lieu of a bus number. The route number is located on the left side of the entry door. Each bus route has been assessed and tested in an effort to make Fraser's transportation system as safe and efficient as possible. **To ensure transportation, all students must be at their bus stop 10 minutes prior to the bus' scheduled arrival time.** To ensure a safe and pleasant ride, please review with your child the bus rules found on the Transportation Department's website.

Fraser Public Schools Launches Second Year of Hybrid Summer Learning

Over 150 students in grades 3–6 participated in a specialized hybrid learning program in Fraser Public Schools this summer. The program offered extended learning in English and math to Fraser Public Schools families.

“Our Hybrid Summer Learning Program is innovative as it continued our focus on learning any time, any place, any pace, and for any path. With the particular age group in our hybrid model this summer, I believe it further supported the culture and expectation that learning will occur using a variety of mediums and on an individual basis,” says Dr. David Richards, Superintendent of Fraser Public Schools.

The program, which only met face-to-face one day each week, used a variety of instructional materials that make the “hybrid” component of the course possible. Software applications such as DreamBox, Newsela, Khan Academy and TenMarks allowed students virtual access to the hybrid model. The District’s learning management system, itslearning, was also used to help manage the content and to individualize student instruction for each child.

“The District wanted to continue offering additional learning opportunities for our students while school is not in session, but understood summer schedules and family vacations can make the traditional summer school model complex,” says Ms. Carrie Wozniak, Assistant Superintendent of Curriculum and Instruction. “By providing every student with an iPad for mobile learning, students had the ability to participate in the hybrid model.”

In the program’s pilot year in 2014, it operated as invitation only. This year, the District was

pleased to welcome all students in grades 3–6 to take part in continuing their learning through the summer months.

“We were very excited to offer a larger, more sophisticated program this year to help reach more of our students in their learning needs over the summer months,” says Wozniak. “It is important to continue the educational process throughout the summer, so student learning continues to grow and the need for remediation is reduced when school resumes in the fall.”

While the program itself offers extended learning for students, the design also perfectly aligns with the professional development Fraser Public Schools offers its teachers. This summer and into the 2015–2016 school year, Fraser Public Schools educators will receive professional development training that directly addresses teaching in hybrid

and blended learning environments, similar to the Hybrid Summer Learning Program.

“The way our teachers are delivering content, assessing student learning, and checking for understanding is very different than the traditional school model. The transformation for our teachers is very much about their professional practice and instructional strategy,” says Dr. Richards.

The program, which concluded at the end of July, cost \$90 and provided students with a meal, snack, and transportation on face-to-face days. For students who qualified as low-income, the fee was waived.

“We are extremely pleased with the success of our hybrid summer program,” says Dr. Richards. “Our staff has truly gone the extra mile in making sure our students have the best learning opportunities each and every day.”

Competency-Based Learning in Fraser Public Schools Offers Customized Path for Students

At Fraser Public Schools, innovative teaching is the norm rather than the exception. To benefit Fraser’s students, the District has made a commitment to creating a learner-centered environment that fosters student leadership and academic excellence through customized learning.

“One of the greatest challenges we are facing in education as a whole is the call to redesign and rethink schools. We must ask ourselves ‘what is in the best interest of our students?’ and determine how we can create a school system that will allow them to demonstrate their mastery of learning on an individual basis,” says Dr. David Richards, Superintendent of Fraser Public Schools.

Through an environment that extends beyond the traditional classroom, students now experience flexibility in learning, in pacing, and in demonstrating their understanding. In Fraser Public Schools, this work is visible through the Competency Based Learning model.

“Competency Based Learning refers to systems of instruction, assessment, grading, and academic reporting that are based on students’ demonstrating that they have learned the knowledge and skills they are expected to learn as they progress through their education,” says Carrie Wozniak, Assistant Superintendent of Curriculum and Instruction.

The overarching goal of the Competency Based Learning model in Fraser Public Schools is centered around the key question: what do we want a Fraser graduate to know and be able to do? By holding students accountable for their learning and promoting a growth mindset, Fraser Public Schools will be able to transform learning for each and every student.

“We are creating life-long learners that will be able to access information, communicate, research, and demonstrate inquiry,” says Wozniak. “We want a Fraser Public Schools diploma to represent much more than a piece of paper.”

Redesigned Learning Space Sparks Ideas in Fraser

At the end of the 2014–2015 school year, Fraser Public Schools unveiled a newly redesigned space for students and staff known as the Idea Lab. This space, found in the 80's wing of Richards Middle School, transformed an outdated training room into a next-generation model classroom.

"This multi-functional space was designed with students and teachers in mind," says Mr. Dan Waters, Director of Operations and Maintenance for Fraser Public Schools. "Each design element within the space was chosen to support student-learning and staff-growth."

The room's once bleak appearance is now rich in color, stimulating creativity and inspiration. Equipped with state-of-the-art materials and technology, the room was also designed to be adaptive.

"The space's movable furniture, writable surfaces, and soft seating options are conducive to a collaborative environment for both adults and students," says Dr. David Richards, Superintendent of Fraser Public Schools.

The room features a green screen, whiteboard walls and desks, along with multiple flat screen television sets for both



individual and group work. The Idea Lab will also serve as a test-bed for new technologies and instructional strategies that might become the standard for Fraser classrooms.

"The birth of the Idea Lab has created the opportunity to have a model classroom for our staff and students. Our goal is to provide new opportunities that will allow us as a District to see how using this space changes the focus of instruction and what new learning opportunities our students will have because of the space," says Richards.

Funded by generous donations from local vendors and remaining bond funds from the 2011 bond proposal, the Idea Lab will be available in the 2015–2016 school year for teachers and students to utilize. Additionally, the Board of Education has adopted the Idea Lab as the new home of the Board of Education meetings.

THE GRIEVANCE PROCEDURE IS ESTABLISHED TO MEET THE REQUIREMENTS OF TITLE II OF THE AMERICANS WITH DISABILITIES ACT OF 1990, TITLE VI OF THE EDUCATION AMENDMENT ACT OF 1972, TITLE IX OF THE EDUCATION AMENDMENT ACT OF 1972, SECTION 504 OF THE REHABILITATION ACT OF 1973, AND THE AGE DISCRIMINATION ACT OF 1975.

Section I: Any person may use this grievance procedure if you wish to file a complaint of discrimination on the basis of race, color, national origin, sex, disability, or age in the programs or activities that are provided by Fraser Public Schools. The grievance may be brought forward to the Local Civil Rights Coordinator, who is identified by name and job title as:

Step 1: A written statement of the grievance signed by the complainant shall be submitted to the Local Civil Rights Coordinator within five (5) business days of receipt of answers to the informal complaint. The Local Civil Rights Coordinator shall further investigate the grievance and reply in writing to the complainant within five (5) days.

of the receipt of such an appeal. A copy of the Board's disposition of the appeal shall be sent to each concerned party within ten (10) days of this meeting.

Step 2: If the complainant wishes to appeal the written decision of the Local Civil Rights Coordinator, he/she may submit a signed statement of appeal to the Superintendent of Schools within five (5) business days after receipt of the Coordinator's response. The Superintendent shall meet with all parties involved, formulate a conclusion, and respond in writing to the complainant within ten (10) business days after receipt of the coordinator's response.

Step 4: If at this point the grievance has not been satisfactorily settled, further appeal may be made to the Office for Civil Rights, Department of Education, 600 Superior Avenue East, Suite 750, Cleveland, OH 44114.

The local Civil Rights Coordinator, on request, will provide a copy of the District's grievance procedure and investigate all complaints in accordance with this procedure.

Section II: The person who believes he/she has a valid basis for grievance shall discuss the grievance informally and on a verbal basis with the local Civil Rights Coordinator, who shall in turn investigate the complaint and reply with an answer to the complainant. He/she may initiate formal procedures according to the following steps.

Step 3: If the complainant remains unsatisfied, he/she may appeal through a signed, written statement to the Board of Education within five (5) business days of his receipt of the Superintendent's response in Step 2. In an attempt to resolve the grievance, the Board of Education shall meet with the concerned parties and their representative within forty (40) days

A copy of each of the Acts and the regulations on which this notice is based may be found in the Local Civil Rights Coordinator's office.

AHERA (ASBESTOS HAZARD EMERGENCY RESPONSE ACT)

The Environmental Protection Agency has determined that airborne asbestos fibers can be a health hazard. The Asbestos Hazard Emergency Response Act (AHERA) was passed in 1986. District buildings are monitored every six months and inspected every three years to comply with AHERA regulations. The last inspection was completed in 2015. Updated Management Plans are located in the office of each building and in the Operations & Maintenance Building. Each Plan shows asbestos-related work that has occurred in each building.

REPRODUCTIVE HEALTH EDUCATION SEX ED INSTRUCTION – STATE AID ACT, 1766A

The Board of Education has established a program of health instruction which includes reproductive health and other sex education instruction, as well as serious communicable disease prevention education.

According to applicable law, parents/guardians have the right to review materials or observe classroom instruction; please contact your student's school principal.

This statute also allows you to excuse your child from participation in classes which include such instruction, if you choose. If you wish to exercise your right to excuse your student from this instruction, please send written notice to your student's school principal.

BADGE SYSTEM FOR VISITORS, VOLUNTEERS AND GUEST TEACHERS

For security purposes, the District is continuing its practice of requiring all visitors, volunteers and guest teachers to wear an identification badge while in any school building. All persons entering a school building are requested to immediately report to the main office to obtain an identification badge.

FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA)

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires that Fraser Public Schools, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child’s education records. However, Fraser Public Schools may disclose appropriately designated “directory information” without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow the Fraser Public Schools to include this type of information from your child’s education records in certain school publications. Examples include:

- A playbill, showing your student’s role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs; and
- Sports activity sheets, such as for wrestling, showing weight and height of team members.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent’s prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965 (ESEA) to provide military recruiters, upon request, with the following information – names, addresses and telephone listings – unless parents have advised the LEA that they do not want their student’s information disclosed without their prior written consent.

If you do not want Fraser Public Schools to disclose directory information from your child’s education records without your prior written consent, you must notify the District in writing by the end of the second week of the school year. Fraser Public Schools has designated the following information as directory information:

- Electronic mail address
- Photograph
- Participation in officially recognized activities and sports
- Degrees, honors and awards received
- Major field of study
- The most recent educational agency or
- Dates of attendance institution attended
- Grade level
- Student ID number, user ID, or other unique personal identifier used to communicate in electronic systems that cannot be used to access education records without a PIN, password, etc. (A student’s SSN, in whole or in part, cannot be used for this purpose.)

DRUG-FREE SCHOOLS

Drug-Free Schools and Communities Act of 1996 (amends Michigan Public Health code) Public 174 of 1994

The “drug-free zone” surrounding school property is 1,000 feet. Any individual who delivers cocaine, narcotics or certain other illicit substances to a minor student within the 1,000-foot drug-free zone around the school property shall be punished by at least two years in prison and up to three times the term of imprisonment and fine – or both – that would otherwise apply. “School Property” is defined as a “building, playing field or property used for school purposes to impart instruction to children in grade kindergarten through 12, when provided by a public, private, denominational or parochial school, except those buildings used primarily for adult education or college extension courses.”

PEST MANAGEMENT PLAN

Dear Parent/Guardian: As a part of the Fraser Public Schools Pest Management Program, pesticides are occasionally applied. You have the right to be informed prior to any pesticide application made to the school grounds and buildings. In certain emergencies, pesticides may be applied without prior notice, but you will be provided notice following any such application. If you need prior notification, you may notify the school district in the following ways:
